Member must present a copy of the Indiana State 4-H Horse & Pony Enrollment Form

All 4-H members must wear ASTM approved helmets

** **PAYBACK** Classes 7 & 15 require 3 or more entries. Payback as follows:

3 – 5 entries 1st - \$20

6 – 9 entries 1st \$25, 2nd - \$15, 3rd - \$5

over 10 entries 1st - \$30, 2nd - \$20, 3rd - \$10 & 4th - \$5

Ribbons 1st - 6th place will be given except for payback classes

* Walk Trot Class entries may only show in Walk-Trot & Warm-Up Classes

* Exhibitor will be disqualified if horse or pony breaks into a canter

Class # 8 - Mini members must provide their own stick horse

Judge's decision is final

Entries close two classes prior to class entering the ring
